## **General Terms and Conditions**

1. All the parties constituting of the Bidders shall be individual Bhutanese or Indian citizen.
  2. The Bidders shall bear all the costs associated with the preparation and submission of Bids, including the visit to examine the disposal of vehicle at site and the DPL shall in no case be responsible for above costs.
  3. The bid form should be submitted in a **sealed envelope** and should be addressed to **Chief Executive Officer, DPL, Nganglam.**
  4. Each page of the bid form must be duly **signed by the bidder**. Non-signing on all the pages of bid form will result in rejection of bid.
  5. The bidder shall submit Citizenship Identity Card copy or Voter Card for Indian national along with the bid.
  6. All the bidders must provide a phone number and an email address to send any link when submitting the sealed bid.
  7. The bidder shall furnish a bid security of **Nu (Rs) 10,000** in the form of bank guarantee/ bank cheque/cash warrant along with the signed offer.
  8. The earnest money of unsuccessful bidders will be refunded immediately after the decision is made by the tender committee to sell the vehicle at the quoted price or not.
  9. The earnest money of the successful bidders will be forfeited if the successful bidder does not deposit the 100% bid amount within 10 working days and the bid will no longer be valid.
  10. The successful bidder is required to pay 25% of the tender amount at the time of acceptance of tender and the balance amount within 10 working days from the date of acceptance, failing which, the offer will be cancelled and the 25% deposit shall be forfeited.
  11. The bid shall remain valid for a period of 30 days from the date of opening.
  12. The inspection of vehicle shall be allowed from 1<sup>st</sup> October to 20<sup>th</sup> October, 2022 during office hours. No further time will be entertained thereafter.

13. It will be assumed that the bidder has inspected the vehicle and is satisfied with the condition of the vehicle.
14. The vehicle may be inspected at DPL, Tshenkari, Nganglam or at Nganglam Town, if bidders are from India.
15. The successful bidder shall lift the vehicle on the day of final payment at their own cost.
16. Ownership transfer of vehicle in the name of successful bidder shall only be done after the full payment of the vehicle is made. Any applicable transfer tax has to be borne by the successful bidder to the RSTA office at the time of ownership transfer as per the RSTA existing rules.
